- 8. Stakeholder Engagement: Understanding the role of stakeholders, such as parents, students, and community members, in implementing the NEP, exploring different strategies for stakeholder engagement, and discussing the importance of building partnerships for successful implementation.

The outcome of an FDP on NEP can be manifold, depending on the goals and objectives of the program. However, some possible outcomes of an FDP on NEP are:



A workshop on Time Management Workshop was conducted for non-teaching staff members at the Shridevi Institute of Engineering & Technology On August 8th 2021.

Workshop Content:

Introduction:
