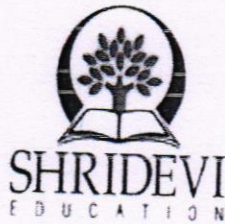

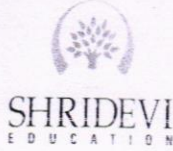



EXECUTIVE SUMMARY


