# RESEARCH POLICY



Shridevi Institute of Engineering and Technology was established in the year 2002 with main objective to focus on teaching, research and extension. Research is one of the important aspects of academic activities which help the institution to achieve excellence in the field of education. Research and developmental activities help to create and disseminate new avenues in knowledge, create interest, promote innovation activities and also motivate better learning and teaching abilities among faculties and students of the Institute. Research activities of the Institute promote research publications, collaborations and bring the awareness on the new innovations. To meet the above all the aspects, Shridevi Institute of Engineering and Technology framed and implemented the Institute's Research Policy.

### **Purpose**

The main aim of the Research Policy is to create a research culture among faculty and students of the Institute. The Research Policy shall serve as an overall framework within which research activities may be carried out. It also aims to identify thrust areas of research having social importance and to contribute towards society and to the nation at large.

### **Scope**

This Research Policy forms the basis of the research ethics of the Institute and is implemented in all the departments. The Research Policy serves as the guidelines for the functioning of the research activities in the Institute.

### **Implementation of the Policy**

The implementation of the Research Policy is the responsibility of the IQAC members of the Institute and function under the guidance and directions of the Principal of the Institute.

### **Objectives of Research Policy**

The main objectives of the Research Policy are as follows:

1. To develop awareness about research among the faculty and students through various research initiatives and by giving due publicity to the socially useful research projects that will be undertaken by the Institute.
2. To establish Research Centre in different departments of the Institute.
3. To encourage faculty members and students to publish research articles.
4. To undertake research projects of social and academic importance.

## **Research Policy**

The Institute has a well-defined Research Policy for the research scholars, teachers and students of the Institute with the following guidelines:

1. Quality basic and applied research in the field of Science and Technology are encouraged.
2. The emerging areas of research are encouraged so that the faculty members can undertake research activities in these areas.
3. Linkage with industries and identifying potential areas of research, surveys and other basic research enquiry are encouraged.
4. The faculty members are motivated and supported to submit and obtain research projects from National Funding agencies like DST, SERB, DBT, ICSSR, VGST, AICTE, VTU, UGC etc.,
5. Financial assistance for publication of research papers and research projects are provided based on quality of Research decided by the committee.
6. Various workshops on research activities are organised to develop appropriate research skills.
7. Faculty members are deputed and supported to participate in workshops, symposia, seminars, conferences, etc., which abet research.
8. Suitable Infrastructure in the Institute which help to carry out different research projects are supported through financial assistance.
